



2022 HIGHLIGHTS

- Held in-person Gala, one of the first in-person gatherings in San Diego as things re-opened following the pandemic. We honored our late founder Don Kojis, with over 600 people in attendance
- Funds from Gala helped complete a new Game Room, in Don's honor. The popular space enhances the camp experience and is especially important during winter months when weather forces groups to stay inside
- Paintball course completed
- Established a partnership with the California Fire Foundation to increase our fire safety objectives, which included clearing brush and distributing fire safety literature on-site and to neighboring communities
- Hired full-time Recreation and Amenities Manager
- Dining Hall features new amenities: cappuccino machine, made-to-order omelets and bagel bar
- More than 1,000 **NEW** campers came to camp on top of our 10,000 returning guests
- Whispering Winds' hosted programs were highly successful, including Traditional, Military and Special Needs Family Camp (celebrated its 10th anniversary,) Senior Moment Retreat, Women's Auxiliary Retreat and Confirmation Retreat
- Collaborated with the Conrad Prebys Foundation to offer a retreat for the Monarch School for high school students impacted by homelessness
- Began a partnership with Life Teen, launching a 5-year strategy to have faith-filled exciting camps for teens during the summer
- Our internet presence more than doubled, including hits to our website, Facebook, Instagram and Twitter accounts
